FromeDrama Membership Privacy Notice

This Privacy Notice sets out how FromeDrama processes and protects your personal data.

Data Controller

Frome Drama Club, a non-registered amateur dramatic society, is the Data Controller for the purposes of the Data Protection Act 1998, which replaced the Data Protection Act of 1984, and the General Protection of Data Regulation (GDPR) of 2018.

Storage and Processing of your Membership Information

- The club stores membership names and email addresses on a password protected data base.
- The club does not hold any records of bank details for standing order payments outside the security of the bank account itself.
- Data held by our Bank for regular payments and transfers is regularly up-dated online by the club's Treasurer.

Membership information is stored securely and may be used only in the following ways:

- To process your annual membership subscription.
- To send you a copy of our newsletter The Script.
- To send you other information that is relevant to your membership of the club.
- To inform you of other local theatre related activities which may be of interest to members.

Third Parties and your information

- FromeDrama uses Microsoft Outlook to store your data.
- Hotmail is used to send you e-mails, always blind copied when circulating the club.
- TSB to process membership subscriptions and payments for production costs and other expenses related to the club's activities.
